# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.landlordlockerroom.com, and The Landlord Locker Room and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Landlord Locker Room include www.landlordlockerroom.com and TLLR. The TLLR website is a E-commerce site. By using the TLLR website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, TLLR may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase TLLR's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or nonpersonal information in the future.

## **Use of your Personal Information**

TLLR collects and uses your personal information to operate and deliver the services you have requested.

# **Sharing Information with Third Parties**

TLLR does not sell, rent or lease its customer lists to third parties.

TLLR may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to TLLR, and they are required to maintain the confidentiality of your information.

## **Tracking User Behavior**

## **Automatically Collected Information**

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
